No. 1, 2 and percentage tenders for Sl. No. 3 to 8 duly filled in all respects may be sent in person or courier or through registered post or ordinary mail so as to reach the hands of bid inviting authority before 3.00 p.m. (as per office clock) on 29.8.2003. Any tender received after the time set forth will not be entertained and will be returned unopened. The Department does not take any responsibility for the delay caused by the courier or postal authorities or the messenger whomsoever may be as appropriate.

Divisional Engineer (H) shall not be responsible for any delay in transit in such cases.

No. 1,2 the bid documents of the qualified bidders will be opened on evaluation and selection of qualified bidders after intimation to them on the date which will be announced later and other bid documents will be returned unopened.

For Sl. No. 1,2 The State level class I contractors of this department with the following norms alone are eligible to obtain the pre-qualification and bid documents.

For Sl. No. 3 to 8 the contractors who have registered in this department in class I are eligible to tender the work.

The contractors who have not participated in tenders for the continuous period of two years and tender schedule purchased but not given as tender for continuously in three tender calls, action will be taken against them for removing their name from register of contractors as per G.O.Ms. No. 21, Highways (HN2) Department, dated 21.1.1999. The Superintending Engineer (H) Tiruchirappalli reserves the right to reject any one or all pre-qualification documents and bid documents without assigning any reasons therefore.

1. Cash / Cheque will not be accepted towards the cost of tender documents and should be remitted in the respective head of account in the Govt., Treasury residing in their respective area of the Division (or) through the D.D. from any scheduled Bank obtained in favour of the Divisional Engineer (H) concerned.
 2. Income Tax clearance certificate and Sales Tax clearance certificate valid for the current period should be enclosed with the tender schedule.
