Any Tender received after the time set forth will not be entertained and will be returned unopened. The department does not take any responsibility for the delay caused by the Courier or Postal Authorities or the Messenger whomsoever may be as appropriate.

Prescribed forms of tender documents shall be purchased on written application up to 8-9-2003 during working days and working hours from the Office of the Divisional Engineer (Highways) Tirunelveli on producing necessary receipted Treasury chalan towards the cost of tender schedules and sales tax and surcharge (not refundable) duly remitted in the following head of account within the jurisdiction of the Divisional Engineer (Highways) Tirunelveli.
