On producing necessary receipted Treasury chalan towards the cost and sales tax and surcharge (Not refundable) duly remitted in the following head of account within the jurisdiction of the Divisional Engineers (H), concerned. The Pre-qualification and Bid Documents and Percentage Tender document duly filled in all respects may be sent in person or Courier or through Registered Post or Ordinary Mail so as to reach the hands of the bid inviting authority before 3.00 PM ( as per Office Clock ) on **15.11.2006**

Any Tender received after the time set forth will not be entertained and will be returned unopened. The Department does not take any responsibility for the delay caused by the Courier or Postal Authorities or the Messenger whomsoever may be as appropriate.

Demand draft drawn in favour of Divisional Engineer (H), concerned from any Scheduled Bank also will be accepted towards the cost of Bid Documents including taxes.

The tender documents will be supplied through registered post or courier to the contractor who makes a request for the same on payment of cost fixed for schedule along with postal charges at their risk and responsibility of the contractor. The Divisional Engineer (H), concerned shall not be responsible for any delay in transit in such cases.

For the works in Sl, No, 1 to 3 and 12, the Pre-qualification Documents alone will be opened by the Superintending Engineer (H) Coimbatore in the presence of the tenderer at 3.15 P.M on **15.11.2006**. Only on evaluation of pre-qualification bids, price bid of the pre-qualified bidders will be opened after intimation of the date later The Price Bid of the unqualified bidders will be returned to them unopened.

In respect of Sl.No. 4 to 11 and 13 to 16 the percentage tenders will be opened at 3.15 PM on the same day (ie) **15.11.2006** in the presence of the tenderers

**NOTE:**

- (1) Sales Tax Clearance Certificate valid for the current period should be enclosed with the tender schedule.
- (2) Regarding the details of Bridge & Road Works concerned the Divisional Engineer (Highways) may be contacted.

- (3) Contractors who have not participated in the tender for the past two years or failed to participate in the tender after obtaining tender schedules for three times their registration of contractorship will be deemed to have been cancelled.
- (4) For the works noted in Sl. No.1,2,4,5 and 6 Tender schedule will be issued only to the contractors, who are having Own Central Hot Mix plant and paver finisher on production of documentary evidence.

**MINIMUM CRITERIA FOR PRE-QUALIFICATION**  
**FOR THE WORKS NOTED IN SL.NO. 1 to 3 and 12**

- (1) The Applicant in the same name and style should have achieved minimum annual turn over ( Defined as Billing for the works in progress and completed) over the last five years at 40% of the value of contract / contracts applied for.
- (2) The Contractor in the same name and style, as prime Contractor should have successfully completed at least one contract ( Highways Road Works/Railways / Airport Authority of India ) of at least 40% of the value of proposed contract within the last five years.
- (3) The experience in similar nature of works should also include the minimum quantity of works executed at least in one work during the last five years ie., 40% of the quantities of major items involved in the proposed work for which pre-qualification has been called for.
- (4) The Contractor should have sufficient Tools and Plants to complete this Work.
- (5) The Contractor should have required Bid Capacity to execute this Work.
- (6) Tenders from such of those Contractors in joint venture arrangements will not be considered.
