For and on behalf of Governor of Tamil Nadu Sealed percentage Tenders will be received by the Superintending Engineer (H), Reserve Line Road, Palayamkottai, Tirunelveli-2 at his office up to 3.00 PM (as per Office Clock) on 10-3-2005 in respect of following works as detailed below for pre-qualification documents and percentage tenders (Two Cover systems). One outer cover containing following two inner cover :

- a) Pre-qualification Documents and EMD in a separate inner sealed cover and
- b) Bid Documents with percentage tender in another Sealed inner cover from the experienced and competent Contractors registered in this Department in Class I with a Money limit of above Rs.25.00 Lakhs (State level) who satisfies the terms and conditions set out in the Pre-qualification Document and Bid Documents, alone are eligible to compete in Tender.

EMD in the shape of Deposit Receipts, Demand Draft and irrecoverable Bank Guarantees issued by the Scheduled Banks or Postal Savings Account, Small Savings Scrips and National Savings Certificates duly pledged to the Divisional Engineer (H) concerned and Indira Vikas Patras which have not matured will be accepted. The Earnest Money Deposit not pledged in favour of the Divisional Engineer (H) concerned will not be accepted and Tenders will be summarily rejected.

Intending Tenderers may obtain prescribed Forms of Pre-qualification and Bid Documents for the above work in person or through their authorised Agents from the Office of the Divisional Engineer (H) concerned up to 7-3-2005 during Office Hours on all working days. The Pre-qualification and Bid Documents duly filled in all respects may be sent in person or Courier or through Registered Post or Ordinary Mail so as to reach the hands of the bid inviting authority before 3.00 PM (as per Office Clock) on 10-3-2005.

Any Tender received after the time set forth will not be entertained and will be returned unopened. The Department does not take any responsibility for the delay caused by the Courier or Postal Authorities or the Messenger whomsoever may be as appropriate.

Prescribed Forms of Pre-qualification and Bid Documents shall be purchased on written application up to 7-3-2005 during working days and working hours from the Office of the Divisional Engineer (H) concerned on producing necessary receipted Treasury Chalan towards the cost and Sales Tax and Surcharge (not refundable) duly remitted in the following head of account within the jurisdiction of the Divisional Engineer (H) concerned .

The tender documents will be supplied through Register Post or Courier to the Contractor who makes a written request on payment of cost and sale tax with postal charges at the risk and responsibility of the contractor. Divisional Engineer (H) concerned shall not be responsible for any delay in transit in such cases.

The Pre-qualification and Bid Documents duly filled in all respects will be received up to 3.00 PM on 10-3-2005 (as per Office Clock) by the Superintending Engineer (H), Tirunelveli his Office at Reserve Line Road, Palayamcottai, Tirunelveli-2.

The Tender Schedules will be issued to the Registered Contractors of this Department who are having their own Central Hot Mix Plant and Paver Finisher. The above plants should be physically available with the Contractors. The new evidence on the purchase of plants such as vouchers, invoice and other connected Documents will not be accepted for the purchase of Tender Documents.

The Superintending Engineer (H), Tirunelveli reserves the rights to reject any or all Pre-qualification Documents and Bid Documents and percentage Tenders without assigning any reason therefore.

MINIMUM CRITERIA FOR PRE-QUALIFICATION

- 1) The applicant in the same name and style as prime Contractor should have achieved minimum average annual turn over (defined as billing for the works in progress and completed) in the last Five years at 40% of the value of contract/contracts applied for.
- 2) The Contractor in the same name and style, as prime Contractor should have successfully completed at-least one contract (Highways road work) of at-least 40% of the value of proposed contract within the last Five years.
- 3) The experience in similar nature of work should also include the minimum quantities of works at-least in a single work by the applicant in the same name and style as prime contractor in any Govt./ Quasi Govt. departments such as Highways/Railways/ Airport Authorities of India etc. during the last five years ie. 40% of the quantity of proposed work for which pre--qualification has been called for.
- 4) The Contractor should have sufficient Tools and Plants to complete this work.
- 5) The Contractor should have required bid capacity to execute this work.

NOTE:

- 1) Pre-qualification Documents cover alone will be opened by the Superintending Engineer (H), Tirunelveli in the presence of the Tenderers or their authorized agents at 3.15 PM on 10-3-2005 at his office. The Bid Documents of the Qualified Bidders will be opened on evaluation and selection of Qualified Bidders after intimation to them on the date which will be announced later and other Bid Documents will be returned unopened.
- 2) Cash / Cheque will not be accepted towards cost of tender documents.
- 3) Sale tax clearance certificate valid for the current period should be enclosed with tender documents.
- 4) Tenders from such those contractors in joint venture arrangements will not be considered.
