E.M.D in the shape of irrevocable bank guarantee issued by the scheduled banks pledged to the Divisional Engineer (H) concerned will also be accepted. The E.M.D not pledged in favour of the Divisional Engineer (H) concerned will not be accepted and tenders will be summarily rejected. The pre-qualification and bid documents duly filled in all respects may be sent in person or courier or through registered post or ordinary mail so as to reach the hands of bid

inviting authority before 3.00 P.M (as per office clock) on **04.08.2005**. Any tender received after the time set forth will not be entertained and will be returned unopened. The Department does not take any responsibility for the delay caused by the courier or postal authorities or the messenger whomsoever may be as appropriate.

Prescribed forms of pre-qualification and bid documents shall be purchased on written application upto **01.08.2005** during working days and working hours from the office of the Divisional Engineer (H) concerned on producing necessary receipted Treasury chalan towards the cost and sales tax and surcharge (not refundable) duly remitted in the following head of account within the jurisdiction of the Divisional Engineer (H) concerned.

Head of Account:

Demand Drafts drawn in favour of the Divisional Engineer (H) concerned from scheduled banks also will be accepted, towards cost of bid documents and sales tax & surcharge.

The tender documents will be supplied through registered post (or) courier to the contractor who makes a request for the same on payment of cost fixed for the schedule along with postal charges at the risk and responsibility of the contractors. Divisional Engineer (H) shall not be responsible for any delay in transit in such cases.

The pre-qualification and bid documents duly filled in all respects will be received upto 3.00 P.M on **04.08.2005** (as per office clock) by the Superintending Engineer (H) Villupuram at his office at 4. Chairman Govindaraj Street, West Shanmugapuram, Villupuram 605 602.

Prequalification documents alone will be opened by the Superintending Engineer (H) Villupuram in the presence of tenderers at 3.15 P.M on **04.08.2005** the bid documents of the qualified bidders will be opened on evaluation and selection of qualified bidders after intimation to them on the date which will be announced later and other bid documents will be returned unopened.

NOTE :-

- 1) The tender schedules will be issued to the Registered Class I (State level) contractors of Highways Department those who are having registration proceeding and contract live proceeding.
- 2) The above works are to be executed by using Central Mixing Plant and Paver finisher confirming the specifications for road and bridge works MORTH (forth revision) with all addenda and corrigenda there to. The Contractors/firms who are having own Central Mixing Plant and Paver finisher alone will be issued the tender schedules on production of documentary evidence for ownership of the Central Mixing Plant and Paver and those who do not produce the documentary evidence of ownership the tender schedules will not be issued.
- 3) Sales Tax Clearance Certificate valid for the current period should be enclosed with the tender schedule.
- 4) Regarding the details of Roads and Works concerned Divisional Engineer (H) may be contacted.

- 5) The contractors who have registered in this department and believe can alone participate in the tender. If they have not participated for two years continuously their registration will be cancelled. Similarly the contractors who have purchased the tender schedules and not participated for three times their registration will also be cancelled as per G.O.Ms.No.21/ Highways (HN2) Dept.dt.25.1.99
- 6) The Superintending Engineer (H) Villupuram Circle, Villupuram reserves the rights to reject any or all the tenders without assigning any reason therefor.

MINIMUM CRITERIA FOR PRE-QUALIFICATION

- 1) The applicant in the same name and style as prime contractor should have achieved minimum annual turn over (defined as billing for the works in progress and completed) over the last Five Years at 40 % of the value of Contract/Contracts applied for
- 2) The Contractor in the same name and style, as prime contractor should have successfully completed at-least one work (Highways Road work/Railways/Airport Authority of India) of value atleast 40 % of the value of proposed contract within the last Five years.
- 3) The experience in similar nature of work should also include the minimum quantities of works execute at-least in one work during the last Five Years i.e. 40 % of the quantities of major items involved in the proposed work for which pre-qualification has been called for.
- 4) The Contractor should have sufficient Tools and Plants to complete this work.
- 5) The Contractor should have required bid capacity to execute this work.
- 6) Tenders from the contractors in joint venture arrangements will not be considered.
- 7) Further particulars if any required in this regard can be ascertained from the Superintending Engineer (H) Villupuram.
