NOTICES:-

1. Cash / Cheque will not be accepted towards the cost of tender documents and should be remitted in the respective head of account in the Government. Treasury residing in their respective area of the Division (or) Demand Draft in favour of the Divisional Engineer (H) Cuddalore from schedule Bank also will be accepted towards cost of bid documents including taxes .
2. Sales tax verification certificates valid for the current year should be enclosed with the tender schedule. .

3 Those who have completed atleast one Bridge work alone are eligible in participation of tender for Bridge work. The tender schedules will be issued only on production of evidence for the same and if the contractors those who are Engineering Graduates (or)Diploma Holders in Civil Engineering are also eligible in participation of Tender for Bridge work.
